MINUTES OF THE MEETING OF THE GOVERNING BODY HELD ON WEDNESDAY, 4TH MARCH, 2015 AT AT 3 :30 P.M. IN THE COLLEGE PREMISES.

A meeting of the Governing Body of the College was held on Wednesday, 4th March, 2015 at 3:30 p.m. in the college premises.

The items on the agenda were taken up ad seriatim and the following decisions were taken:

1. To confirm the Minutes of the Governing Body meetings held on 28th November, 2014 and 23rd February, 2015 and the matters arising out of the Minutes (Annexure-I and II).

2. The Principal further informed that the bill has been examined and the amount due is as per the terms of payment approved by the Governing Body in this regard. He further reported that a 'on account' payment of Rs.1,50,000/- was made to the Architect vide order of the Chairman, Governing Body dated 10.02.2015.

The Governing Body considered the matter and approved the payment of fee of Rs.1,86,608/to M/s. Architect Studio Plus. The Governing Body also ratified and confirmed the order of the Chairman, Governing Body dated 10-02-2015 regarding an 'on account' payment of Rs.1,50,000/- made to M/s. Studio Plus and decided that the remaining amount be paid to M/s. Architect, Studio Plus.
