## MINUTES OF THE MEETING OF THE GOVERNING BODY HELD ON THURSDAY, 28<sup>th</sup> FEBRUARY, 2019 AT 4:00 P.M. IN THE COLLEGE PREMISES.

The items on the agenda were taken up ad seriatim and the following decisions were taken:

1. To confirm the Minutes of the meeting of the Governing Body held on 15<sup>th</sup> November, 2018 and the matters arising out of the Minutes.

<u>The Governing Body ratified and confirmed</u> the minutes of the meeting of the Governing Body held on 15<sup>th</sup> November, 2018. There was no matter arising out of the Minutes.

2. To ratify and confirm the approval of the Chairman, Governing Body dated 13-02-2019 accepting the resignation of Dr. P.K. Khurana from the post of Principal, Shaheed Bhagat Singh College (Day) vide his request dated 13-02-2019 and to consider the request of the Chairman, Governing Body dated 13.02.2019 made to Dr. Khurana to continue till Acing Principal is appointed and takes charge of the Office of the Principal.

<u>The Governing Body ratified and confirmed</u> the approval of the Chairman, Governing Body dated 13-02-2019 accepting the resignation of Dr. P.K. Khurana from the post of Principal, Shaheed Bhagat Singh College (Day) vide his request dated 13-02-2019. The Governing Body also ratified and confirmed the request of the Chairman, Governing Body dated 13.02.2019 made to Dr. Khurana to continue till Acing Principal is appointed and takes charge of the Office of the Principal.

**Note:** Dr. P.K. Khurana functioned as Officiating Principal/O.S.D. of Day Collge w.e.f. 12.12.2007 to 25.08.2009 and again from 01.04.2012 to till he took charge as regular Principal of Day College on 03.07.2015 (A/N) on the recommendation of the

duly constituted Selection Committee and approval of University of Delhi. He was given additional charge of Evening College as Acting Principal since then to date (except from 25.06.2018 to 30.11.2018). Dr. Khurana would join Evening College as Principal as he is on extra ordinary leave with lien from Evening College w.e.f. the date he is relieved from Day College.

3. To consider and approve the recommendation of the Screening Committee to make necessary arrangement of Acting/Officiating Principal, Shaheed Bhagat Singh College in terms of Clause VII (3) of Ordinance XVIII of the University of Delhi.

It was reported that Dr. P. K. Khurana joined on 03 July, 2015 as Principal, Shaheed Bhagat Singh College Day after obtaining Extra-Ordinary Leave (EOL) with lien from the post of Prinicpal, Shaheed Bhagat Singh (Evening) College. However, he was directed by the Governing Body to look after the Evening College as its Acting Principal and this proposal of the Governing Body was approved by the University of Delhi vide its letter No.CS-SDC/114/Prin-SBSC(M)/2015/270 dated 21<sup>st</sup> July, 2015 till further order.

It was further reported that Dr. Khurana vide his letter dated 13<sup>th</sup> February, 2019 has requested the Chairman, Governing Body to relieve him of the charge of the Principal of Shaheed Bhagat Singh College. In order to make immediate appointment for Acting/Officiating Principal in terms of Clause VII (3) of Ord XVIII of the University of Delhi, the Chairman, Governing Body invited applications from eligible Associate Professors vide his Notice dated 13-02-2019 which was sent by email to all the Associate Professors, published on the College Website and put up on the Staff Notice File for wider publicity. Those Associate Professors who did not have the email, were informed in person.

As per College records, there are 20 Associate Professors on the rolls of the College as on 13.02.2019. Of the 20, the following 06 Associate Professors were not eligible as they do not hold Ph.D. Degree:

It was further reported that the Screening Committee as per guidelines of the University of Delhi was constituted to screen the above two applications to determine whether they meet the requirement of consolidated API score of 400 points from Category-II and III on API (cumulative). The Screening Committee met on 26<sup>th</sup> February, 2019 at 3:00 p.m. The minutes of the Screening Committee held on 26<sup>th</sup> February, 2019 were placed before the Governing Body. (Annexure-I). After considering the matter in detail, the Governing Body approved the recommendation of the Screening Committee that the name of Dr. Anil Sardana be approved for appointment as Acting/Officiating Principal of Shaheed Bhagat Singh College.

This Resolution of the Governing Body be forwarded to the University of Delhi for its approval.

4. To ratify and confirm the approval of the Chairman, Governing Body dated 18.01.2019 regarding grant of 'Sabbatical Leave' to Dr. Anil Sardana, Associate Professor in the Department of Commerce for another period of one month w.e.f. 20-01-2019 to 19-02-2019 to improve knowledge and competence in the field of Skill Development, Entrepreneurship and Leadership to enable him to impart quality education to the students of the College.

<u>The Governing Body ratified and confirmed</u> the approval of the Chairman, Governing Body dated 19.02.2019 to accept the resignation of Ms. Naina Karol, Assistant Professor in the Department of Commerce of the College w.e.f. 20.12.2014 (A/N) vide her request dated 31.01.2019 as she has been confirmed as an IRS Officer on 22.12.2016 vide Notification No. 20 dated 31.12.2018 issued by Department of Revenue, Ministry of Finance, Government of India.

**Note:** Ms. Naina Karol was earlier granted 'Extra-Ordinary Leave' for the periods from 20-12-2014 to 19-12-2015, 20-12-2015 to 19-12-2016, 20-12-2016 to 19-12-2017 and 20-12-2017 to 19-12-2018.

To ratify and confirm the approval of the Chairman, Governing Body dated 18.01.2019 regarding grant of 'Study Leave' to Mr. K. Krishnadas, Assistant Professor in the Department of Mathematics for another period of one year w.e.f. 21.02.2019 to 20.02.2020 to complete his Ph.D from National Institute of Technology, Manipur.

<u>The Governing Body ratified and confirmed</u> the approval of the Chairman Governing Body dated 19.12.2018 approving the re-appointment of the aforesaid Assistant Professors on ad-hoc basis in different departments as mentioned against their names in the Pay of Rs.57700/-, as per 7<sup>th</sup> CPC, in accordance with the guidelines issued by the University of Delhi w.e.f 1<sup>st</sup> January, 2019 for a period of 04 months or till such time appointments on regular basis are made / leave vacancy exists, whichever is earlier.

<u>The Governing Body approved</u> the appointment of Dr. Ranjana as Assistant Professor in the Department of Commerce on ad-hoc basis in the Pay of Rs.57700/-, as per 7<sup>th</sup> CPC, in accordance with the guidelines issued by the University of Delhi w.e.f 15.01.2019 or till such time regular appointments take place / leave vacancy exists, whichever is earlier.

9. To consider and approve the Report received from 03 Independent Members Committee constituted by the Governing Body of the College vide Order dated 29.06.2018 to scrutinize/examine the cases pertaining to CPF/GPF in respect of retired/to be retired employees of Shaheed Bhagat Singh College.

<u>The Governing Body noted that</u> the 03 Independent Members Committee is required to be constituted as per University of Delhi letter Nos. Fin/Pen.Cell/CPF-GPF/2017 dated 10.08.2017 and Fin/Pen.Cell/CPF-GPF/2017/47 dated 08.01.2018 to scrutinize/ examine the cases pertaining to CPF/GPF in respect of retired/to be retired employees of Shaheed Bhagat Singh College. The Governing Body of the College vide its Order dated 29.06.2018 constituted 03 Independent Members Committee comprising of the following:

- (ii) Sh. Girish Pandey, Senior Advocate, Delhi High Court
- (iii) Shri L.R. Luthra, Senior Advocate, Delhi High Court, 66 South Park, Kalkagi, New Delhi-19

Ms. Justice Manju Goel (Retired) was nominated as the Chairperson of this Committee.

The aforesaid Committee has submitted its report vide letter dated 25.02.2019 and concluded that "the teachers Mr. Abdul Salam, Mr. Surjeet R. Dhillon, Dr. Jamuna Prasad, Mr. Shyam Sunder, Dr. B.B. Goenka, Mr. R.C. Jain, Mr. A.K. Kharbanda, Ms. Vijay Lakshmi Dudeja, Mr. Anil Sardaan were in service on 01.01.1986 and they did not, in compliance with the OM dated 01.05.1987, submit any option to continue in the CPF Scheme. In view of the above evidence produced before the Committee and the observations by the Committee members on inspection of each and every file in respect of each teacher, the Committee is fully satisfied that the teachers above named fall in Category III and are entitled to the benefit of GPF cum Pension Scheme."

After considering the Report, the Governing Body resolved to approve the said report and decided that the cases of retired employees be sent to the University of Delhi for fixation of pension along with required documents.

**Note:** The College received a letter No. Fin/Pen.Cell/CPF-GPF/2017 dated 10.08.2017 from Finance Officer, University of Delhi through email dated 10.08.2017 regarding implementation of the Division bench judgment in respect of non-petitioners of Category-III (Virmani Batch). The letter was placed before the Governing Body at its meeting held on 21.08.2017. It was noted that no member of the Committee should be directly linked with the College/DU and one member may be from the judicial background. This Committee shall examine the records of the retired employees and has to satisfy itself that the particular retired employee, who is non-petitioner, has not submitted any form to continue under the CPF Scheme on or before 30.09.1987 and also to ensure that he/she is falling under category-III (Virmani batch).

It is further submitted that in continuation of letter no. Fin/Pen.Cell/CPF-GPF/2017 dated 10.08.2017, University of Delhi vide letter no. Fin/Pen.Cell/CPF-GPF/2017/47 dated 08.01.2018 clarified that "one member of the three member independent committee to be constituted by the Governing Body of the College to scrutinize/examine individual case files in respect of non-petitioners of category-III (virmani batch) may be from the judicial background. The said member of the Committee may be a retired judge".

Based on the consultation, the Committee comprising of the following 03 independent members was constituted:

Ms. Justice Manju Goel (Retired) was nominated as the Chairperson of this Committee.

10. To consider and approve the proposal received from the Coordinator, International Coordination and Development Programme (ICDP) to charge Rs.300 per student to meet the expenditure on the activities of this programme with effect from the academic session 2019-20.

The Governing Body considered the proposal received from the Coordinator, International Coordination and Development Programme (ICDP) to charge Rs.300/per student to meet the expenditure on the activities of this programme with effect from the academic session 2019-20. It was resolved that the proposal of the ICDP be approved and an amount of Rs.300/- per student be charged from the academic session 2019-20 to meet the expenditure on the activities of this programme.

  - a) Dr. P.K. Khurana, Principal informed the Governing Body that he has constituted a Committee for the construction of cemented stage in the Central Lawns of the College as well as in the play ground of the College for the conduct of various programmes by the students society/committees and inter-college cultural-cumunion fest in the play ground. It was also noted that College would save lot of money which is being spent on payment to the tent house for erection of the stages. The Governing Body appreciated this initiative and approved the same for implementation in the College.
  - b) The Governing Body put on record its appreciation of the services rendered by Shri Abhishek Gupta as Chairman, Governing Body and Shri Narendra Kumar as Treasurer and other members of the Governing Body of the College for bringing out all round improvement in the College.
