The process of adjustment of TDS is supported by the Income Tax Rule Section 139(5) of the Income Tax Act, 1961. The tax payers are allowed to rectify their mistakes by filing a revised income tax return under 139(5). Accordingly, the same was done in the case of Dr. Shantesh Kumar Singh.

Note: The College received a letter dated 09-07-2022 from Dr. Shantesh Kumar requesting to review/revise/rectify the decision made/recorded in the meeting of the Governing Body dated 04-09-2020 in the line of GB decision to consider the request dated 22-01-2020 to refund the full amount, i.e., Rs.10,09,511/- deposited by him for complete period of Study Leave, i.e., 10th months and 13 days.

After examination the records/file in respect of Dr. Shantesh Kumar, it was noted that the wrong interpretation on the request dated 22-01-2020 received from Dr. Shantesh Kumar was recorded in the minutes of the Governing Body where he has requested to deposit the proportionate amount till the time decision is pending but later he was asked to deposit the full amount. However, while recording the approval of refund of amount in the minutes of the Governing Body, it was recorded that the proportionate amount be refunded rather than the full amount.

14. Accordingly, the College has sent a letter No. SBSC/866 dated 15-11-2022 as desired by Governing Body. In response to College letter, a reply has been received from the Deputy Registrar, University of Delhi, South Campus vide letter No. CS-SDC/112/2022/SBSC/234 dated 16.11.2022. As per said letter, the University directed the College to take appropriate action as per extant rules and the communication received from the University vide letter no.CS-III/MTS/Misc./2022/219 dated 14.06.2022 in which it is mentioned that the appointment of MTS, i.e., Office Attendant, Daftry, Farash, Mali, etc. are to be filled through outsourced basis only as the same was accepted and adopted by the EC of the University of Delhi vide Resolution No.24 (45) dated 28.05.2015).

The Principal further informed that since the University has again communicated to the College that the appointment of MTS, i.e., Office Attendant, Daftry, Farash, Mali, etc. are to be filled through outsourced basis only as approved aforesaid EC Resolution, the College

may not continue the services of Mr. Suraj Pal as MTS on compassionate ground on Permanent basis. Therefore, his services as MTS on compassionate ground be discontinued with immediate effect and he may be appointed as MTS as per University Rules.

The Governing Body considered the communication received from the University of Delhi as aforesaid and approved that the services of Mr. Suraj Pal as MTS on compassionate ground be discontinued with immediate effect and he may be appointed as MTS as per University Rules.
